You do not need to file a 1099 to contractor if your business paid them less than \$600 during the financial year. But if you paid them more than \$600 for services rendered, rent, in the form of prizes or awards, or for any other type of miscellaneous income payment, you need to file a 1099. Keep in mind, there are a couple of exceptions to this rule.

If you file through snail mail, you must mail Form 1096 and Copy A of each Form 1099 to the IRS no later than February 29; if you're filing electronically, the forms must be sent out by March 31. 6.

How Do I Prepare and File a 1099? Follow these steps to prepare and file a Form 1099: Obtain a blank 1099 form (which is printed on special paper) from the IRS or an office supply store. Fill out the 1099. Each Form 1099

comes with 5 copies, so make sure to write or type on the top copy so it transfers down onto each copy, like carbon paper. Send Copy A to the IRS. Copy 1 to the appropriate [Am I Required to File a Form 1099 or Other Information ...](#)

Do not file Copy A of information returns downloaded from the IRS website. The official printed version of the IRS form is scannable, but the online version of it, printed from the website, is not. A penalty may be imposed for filing forms that cannot be scanned.
